## **Additional Information**

The information below indicates additional information that the organisation included in their APCO Annual Report.

Describe initiatives, processes or practices that you have implemented during your chosen reporting period that have improved packaging sustainability

Packaging workshops held in September 2022 created multiple changes, including switching from nonrecyclable soft plastics like PVC to LDPE in various Dri-Glo and Home products. Rigid plastic boxes have been switched to cardboard boxes in Blinds packaging, laminates have been removed from paper/cardboard products including various header cards and we have found a more sustainable kimble tie that contains recycled content. Paper/cardboard is prioritised over plastics where viable.

#### Describe any opportunities or constraints that affected performance within your chosen reporting period

In the value sector of the market, prices often limit our capacity to switch to more sustainable options. There are elements of our packaging that are very difficult to switch to a more sustainable option. For example kimble ties and elastic ties prove a significant issue, along with the requirement of soft plastic carton liners to protect our product. The collapse of soft plastics recycling also halted a large amount of work we had done in moving non recyclable soft plastics to recyclable soft plastics.

We developed cardboard hangers to be used for Mambo thongs and slides as an alternative to plastic hangers. Rather than being individually wrapped for B2B packaging, we are using one large carton liner with a cardboard insert to divide the 8 pairs of slides per carton.

- Regularly engage or communicate with our external stakeholders about the environmental impacts of our packaging.
- Actively participate in initiatives to promote packaging sustainability outside of our organisation.

#### Criteria 2:

#### Design & Procurement:

This criteria considers actions taken to ensure that sustainability principles are considered in the design or procurement of both new and existing packaging through use of the Sustainable Packaging Guidelines (SPGs).


- Review 90% of our packaging against the Sustainable Packaging Guidelines (or equivalent).
- Improve the accuracy of our data regarding reviews of packaging using the Sustainable Packaging Guidelines (or equivalent).
- Incorporate the Sustainable Packaging Guidelines (or equivalent) into procurement processes.
- Consider the following Sustainable Packaging Principles in our packaging reviews:
  - Design for recovery
  - Optimise material efficiency
  - Design to reduce product waste
  - Eliminate hazardous materials
  - Use of renewable materials
  - Use recycled materials
  - Design to minimise litter
  - Design for transport efficiency
  - Design for accessibility
  - Provide consumer information on environmental sustainability
- 5% of our packaging to be optimised for material efficiency.

#### Criteria 3: Recycled Content:

This criteria considers actions taken to increase or optimise the amount of recycled material used by your organisation.

- Develop a policy or procedure to buy products and/or packaging made from recycled materials.
- Use recycled content in:
  - Our products
  - Primary packaging that we use to sell our products
  - Tertiary packaging that we use to sell our products
  - 65% of our packaging to be made using some level of recycled material
- Improve the accuracy of our data regarding use of recycled materials.

Criteria 4: Recoverability:







This criteria considers actions taken to improve the recovery of packaging at end-of-life and increase use of reusable packaging.

- 10% of our packaging to be designed to have all packaging components be recoverable at end-of-life.
- Improve the accuracy of our data regarding recoverability.
- Use PREP to assess the recyclability of our packaging through kerbside collection in Australia and/or New Zealand.
- Aim to have **100**% of our compostable packaging certified to Australian standards.
- Investigate opportunities to use reusable packaging.

#### Criteria 5:

#### Disposal Labelling:

This criteria considers the extent to which packaging has been labelled to help consumers determine what to do with packaging at end-of-life.

- 30% of our packaging to have on-pack labelling to inform correct disposal.
- Improve the accuracy of our data regarding labelling.

#### Criteria 6:

#### On-site Waste:

This criteria considers progress in increasing the amount of on-site solid waste being diverted from landfill.

- Have recycling programs for the following materials:
  - Paper/cardboard
  - Soft plastics
  - Rigid plastics
  - Textiles
  - Glass
  - Metals
- Aim for 88% of our on-site waste to be diverted from landfill.
- Improve the accuracy of our data regarding on-site waste.

## Criteria 7:

#### Problematic Materials:

This criteria considers the extent to which organisations are actively phasing out problematic and unnecessary single-use plastic packaging and preventing/reducing litter.

- Phase-out the following problematic and unnecessary single-use plastic items:
  - Rigid plastic packaging with carbon black
